

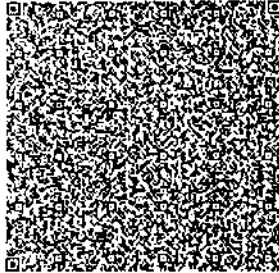

**MEMORANDUM OF UNDERSTANDING**

BETWEEN

**KLE'S RAJA LAKHAMAGOURA SCIENCE INSTITUTE  
(AUTONOMOUS), BELAGAVI**

AND

**S. NIJALINGAPPA SUGAR INSTITUTE, BELAGAVI**

ON

**Research & Development and Training cum Short Term certification  
courses on Sugar Manufacture and related areas**

This **Memorandum of Understanding** is intended to develop and promote regional scientific cooperation between the KLE's Raja Lakhamagouda Science Institute (Autonomous), Belagavi and the S. Nijalingappa Sugar Institute, Belagavi.

KLE's Raja Lakhamagouda Science Institute (Autonomous), Belagavi, represented by the Principal and the S. Nijalingappa Sugar Institute, Belagavi, represented by the Director, recognizing the needs and benefits to their institutes from the establishment of institutional links, hereby agree to enter into this agreement for the following purpose:

KLE's Raja Lakhamagouda Science Institute (Autonomous), Belagavi, was established in the year 1935 in the Indian State of Karnataka and the institute is affiliated to Rani Chennamma University, Belagavi for rendering excellent educational, scientific and knowledge services to society.

S. Nijalingappa Sugar Institute, formerly, Karnataka Sugar Institute at Belagavi, is a research institute registered under Karnataka Society's Registration Act 1960 to undertake sugarcane & sugar industrial related research and development activities in the interest of cane growers and sugar industry, on the lines of National Sugar Institute, Kanpur in Uttar Pradesh and Vasantdada Sugar Institute, Pune in Maharashtra.

## **1. PURPOSE OF AGREEMENT**

The purpose of this agreement is to develop scientific, academic and educational cooperation, establish a collaborative program in Sugarcane & Sugar Industrial related Research between the two institutions and to cooperate in their mutual interest for a range of higher educational and scientific activities.

## **2. AREAS OF COOPERATION**

Subject to the availability of expertise, manpower, resources and approval of KLE's Raja Lakhamagouda Science Institute (Autonomous), Belagavi and the S. Nijalingappa Sugar Institute, Belagavi or their authorized representatives, both institutions agree to develop the following collaborative activities in academic and scientific areas of mutual interest:

- (a) Organization of lectures, symposia, international meetings, conferences, and workshops
- (b) Providing opportunities for faculty and researchers to share knowledge
- (c) Mutual cooperation in individual projects

- (d) Conducting joint research and development projects
- (e) Exchange of information, teaching materials, technological and scientific publications
- (f) Training of researchers and mutual exchange of research ideas
- (g) Search for opportunities to collaborate in the future at regional, national or international levels
- (h) Joint publications on research areas of mutual interest in the form of journal articles, book chapters, books and laboratory manuals, and
- (i) Scientific support to students and PhD scholars on mutual areas of research interest.

### **3. IMPLEMENTATION**

- 3.1. All activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing, including the necessary approval for the program of activity as the need may arise.
- 3.2. Each of the participating institutions shall be fully responsible logistically and financially for the activities carried out under its direction or by its staff, except as otherwise agreed by the parties.
- 3.3. The parties will designate one scientific representative each who will develop and coordinate specific programs or activities between them.
- 3.4. Principal, Dr.V.D.Yalamali of KLE's Raja Lakhamagouda Science Institute (Autonomous), Belagavi, and Dr. R. B. Khandagave, Director, S. Nijalingappa Sugar Institute, Belagavi will be the scientific representatives for both these institutions who will develop and coordinate collaborative activities.

### **4. FINANCIAL IMPLICATION**

- 4.1. This MoU is a non-financial MoU and does not involve funding as an obligation on both the parties.

### **5. DURATION AND RENEWAL OF AGREEMENT**

This Memorandum of Understanding will become effective immediately after signature by the representatives of KLE's Raja Lakhamagouda Science Institute (Autonomous), Belagavi and representatives of S. Nijalingappa Sugar Institute, Belagavi for a period of ten years and is subject to revision or modification by mutual agreement.

### **6. AMENDMENTS**

- 6.1. This Memorandum of Understanding may be amended by a written agreement signed by the representatives of both institutions.

6.2. In the event of any unforeseen incident during collaborative activities in either institution, both institutions agree to negotiate a mutually acceptable solution.

6.3. Should any disagreement arise out of the application, interpretation or implementation of this Agreement, both the parties shall endeavor to exercise best efforts to negotiate their differences.


## 7. TERMINATION OF AGREEMENT

At any time during its period of validity, this agreement may be terminated by either party upon prior notice to the other in writing not later than two months before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.
